THE HONOURABLE GARY DOER

FORMER AMBASSADOR OF CANADA TO THE UNITED STATES FORMER PREMIER OF MANITOBA



The Honourable Gary Doer served as the Ambassador of Canada to the United States from 2009 to 2015 and Premier of Manitoba from 1999 to 2009. Currently, he serves as the Co-Chair of the Canada Institute Advisory Board

During his term in Washington, Doer helped to launch important new initiatives to speed

up border crossings and eliminate red tape for exporters. He helped Canada to enter the Trans-Pacific Partnership negotiations and finalized a deal to build the new Gordie Howe International Bridge between Windsor and Detroit. And, he worked to ensure that Canadian hydroelectricity is classified as a renewable energy source by the United States government, securing key export markets for hydro producers in Manitoba, Quebec, Ontario, and Newfoundland.

As Premier of Manitoba, Doer worked extensively with U.S. Governors to enhance Canada-U.S. cooperation on trade, agriculture, water protection, climate change and renewable energy. He won three consecutive elections as Premier with successive increased majorities. In 2005, he was named by Business Week magazine as one of the top 20 international leaders on climate change. His government introduced balanced budgets during each of his ten years in office while also reducing taxes. As Premier, he led strategic investments in health care, education, and infrastructure. Doer is married with two daughters.
